Lakeridge expects to drop about 20%.

Test and standards have risen. Lakeridge students are more proficient than ever before but the new testing has raised the standards. Students are learning more but the results do not reflect that yet. This is a pilot test. Standards are significantly higher on the Sage Test. It is a very lengthy test.

Teacher Goals:

- \*Continue to work on two lowest standards
- \*Use High Yield Strategies to Improve instruction (reflection, posted objective, etc.
- \*Administration observe the teaching of at least one goal.

LEAP Class

Purpose-help students learn about brain, growth mindset, coping strategies & leadership skills  
So we are able to reach them academically  
24 students this semester. Two sections next semester  
Princeton is coming to administer pre-testing for data collection on this, and a control group, to  
Determine if we are effective.

Get students change own behavior – not just massive amount of work by teachers
