PARENT/GUARDIAN AFFIDAVIT

I, _____, Parent/Guardian of the above named school-age minor(s), in accordance to Utah State Law, Section 53G-6-204, declare my intent to home school my student(s). I assume sole responsibility for the education of the school-age minor(s) except to the extent that the student is dual-enrolled in a public school, Section 53G-6-702. I recognize I am solely responsible for:

- 1) The selection of instructional materials and textbooks;
- 2) The time, place, and method of instruction; and
- 3) The evaluation of home school instruction.

I accept full responsibility for my student and I understand that my student may not qualify for a high school diploma issued by Alpine School District or any of its schools unless the student meets all Alpine School District graduation requirements. This affidavit shall remain in effect as long as:

- 1) The school-age minor attends a home school; and
- 2) Alpine School District remains the school-age minor's district of residence
- 3) The parent or legal guardian who filed the signed and notarized affidavit has not been convicted of child abuse or been the subject of a substantiated finding of child abuse by a court of competent jurisdiction.

(For students with IEPs or identified through child find): My decision to home school does not in any way imply that the school district did not provide a free and appropriate public education and I understand and agree that my student has no individual right to receive some or all of the special education and related services he/she would receive if enrolled in a public school in Alpine School District, unless I have arranged for dual enrollment consistent with state law, Section 53G-6-702. I understand any request for special education service/access will be determined by the IEP Team. I have read this agreement and understand my obligations as a home school parent.

NOTE: If a parent or legal guardian has been convicted of child abuse or if a court of competent jurisdiction has made a substantiated finding of "child abuse" against the parent or legal guardian, the parent or legal guardian **may not assume responsibility for the education of a school-age child** under Subsection (2)(a)(ii). "Child abuse" is defined as the following conduct: child abuse under Section 76-5-109, aggravated child abuse under Section 76-5-109.2; child abandonment under Section 76-5-109.3; commission of domestic violence in the presence of a child under Section 5676-5-114 ; child abuse homicide under Section 76-5-208; child kidnapping under Section 76-5-301.1; human trafficking of a child under Section 76-5-308.5; an offense described in Title 76, Chapter 5, Part 4, Sexual Offenses, or in Title 6176, Chapter 5b, Part 2, Sexual Exploitation, if the victim is under 18 years old; sexual exploitation of a minor under Section 76-5b-201; aggravated sexual exploitation of a minor under Section 76-5b-201.1; or an offense in another state that, if committed in this state, would constitute an offense described in this Subsection (2)(a)(i).
